

Noon duties have attended various trainings and are funded by LCAP; may increase student support Bree will define noon-duties duties and will inform staff as to their capacity to support staff and students

## c. 6<sup>th</sup> Grade Camp Funding Request

Two teachers are seeking \$2700 funding to have 6<sup>th</sup> graders attend virtual camp; Teachers shared their opinion regarding attending 6th grade camp; DI students will have an opportunity to interact with other students; Camp Cuyamaca is \$45 per student (45 x 60 = \$2,700) for the first week or second week in May; 5-day program; includes synchronous and asynchronous activities; Mrs. Mora has contacts that she's willing to approach to assist with shirts and printing.

Mr. Anderson suggests the funds be used for a different activity; he prefers an alternative to a "virtual" camp participation; Mrs. Mora said it's important to give students an opportunity to participate, even if not all students choose to engage and/or participate; Mrs. Mora shared that some families would participate and believe the virtual camp is a good opportunity to give students an option to participate.

Bree shared 6th grade parent choice for Q4 attendance; It would remain an information item and a special voting meeting will be held in 3 days at 3:15.

6th grade account: \$1600 for promotion, end-of-year activities, and shirts, goody-bags;

Bree will contact Camp grounds to seek a better rate or deal for our school; parents may contribute to end-ofyear costs; A special SSC meeting will be scheduled on Thursday at 3:15 to approve funding for 6th grade camp; Mr. Anderson would like to know if voting can be done by email; Bree will look into it.
